

## CITY COMMISSION ROOM PIERRE, SOUTH DAKOTA March 31, 2020

The City of Pierre Board of Commissioners met in regular session on March 31, 2020 at 5:30 pm with Commissioners Barringer, Huizenga, Johnson, Mehlhaff, and Mayor Harding present for roll call. The Pledge of Allegiance was recited followed by an invocation. The agenda was approved as amended. The Wastewater Treatment Plant Facility Improvements item and executive session was removed. Pete Obermeier was present for public comment.

## Mayor Harding recused himself from the meeting.

Twila Hight, Finance Officer, explained that Caleb Gilkerson turned in petitions on Monday March 23rd to run for Mayor claiming residency at 511 W Dakota Avenue, however an issue with the notary stamp deemed the petitions invalid. Caleb then secured 59 signatures and turned in valid petitions on Monday March 30<sup>th</sup>. The address claimed as residency is noted to be Steamboats Inc. as per the City Utility records and verified with Secretary of State's Office as the business address. After researching City records to determine if a residence was located within the business, there was no evidence found that this was ever used as a residence. The property is zoned Local Business, so a residence would require a Special Use Permit from the City. Building Permits on file did not show any reference to a residence, which would have required a building permit and would have been inspected by City staff to complete the permits. The County Records were also pulled and also did not reference any living space, bedrooms, or bathrooms. Based on the information and evidence found, the determination was made that Caleb did not meet the qualifications of residency as required by State Law, City Ordinance, and the City's Home Rule Charter. Richard Tieszen was hired to provide a legal opinion regarding the information and evidence that was found. Mr. Tieszen explained that his determination supported the Finance Officer's determination, adding that in 1999 the City passed an Ordinance that changed the allowable use of this particular property and would have required a filed grandfathered residential use. There is no record of a residence or request to be grandfathered as such. In 2002 Caleb Gilkerson filed for a variance to construct an addition onto the property and another building permit was obtained to complete this work. The floor plans provided and verified by inspection, do not show any residential space. Additional building permits were obtained in 2005 and 2008, also requiring building inspection. Again, no residential space was noted. The determination was provided to Caleb in writing on Friday March 27<sup>th</sup>. The letter explained the findings and provided that the City's Home Rule Charter required the Commission to be the final judge of elections and qualifications of it's members, noting the item would be reviewed at the March 31st City Commission Meeting. Caleb commented that he would like more

time to secure legal council, however it was noted that the notice of Election must be delivered to the County by April 1st. He went on to say this is his home and he lives there. He indicated he had an apartment put in for his customers to stay and many people do stay there. He said him and his son stay there. He explained that he's lived many places, including the house on 8th Street with his girlfriend Jess Burchill, but when she moved to Stanley County, he moved into 511 W Dakota Avenue. He was asked if all his belongings are located at this address and he indicated he had belongings in many places, including his parent's house. He was asked if he spends the majority of his nights at this location and he answered that he does not. This is where he goes every day and intends to go back to when he leaves. Commissioner Huizenga moved and Commissioner Johnson seconded to concur with the decision made by Twila Hight, our Finance Officer, that Caleb Gilkerson is not qualified to be legal candidate for Mayor for the City of Pierre based on not meeting the residency requirement. Unanimous approval.

Mayor Harding rejoined the meeting.

This being the time and place for the public hearing to consider the State Revolving Fund Loan Application for the Wastewater Treatment Plant Improvement Projects, Mayor Harding opened the hearing. Twila Hight, Finance Officer, explained that the application is for \$15.3 million to redesign the Wastewater Treatment Plant. Burns & McDonnell has been working on the plant improvements after the phase 1/2 was completed. They filed the original facility plan, but continued work on the redesign required an amendment to the Facility Plan that will be brought back to the Commission in the near future. This will be the last project that completes all needed improvements at the Plant. Being no one else present to comment, Mayor Harding closed the hearing. Commissioner Barringer moved and Commissioner Mehlhaff seconded to approve the Application to DENR SRF for the Wastewater Plant Improvement Redesign Project and authorize the Mayor to sign. Unanimous approval.

Sharon Pruess, City Planner, presented a request to hold a hearing for a Conditional Use Permit at 220 W Dakota Avenue from Quality Rentals/Brett Wheelhouse. His proposal includes renovations to the property to construct 20 small apartment units with 1 or 2 bedrooms. The final plans will be refined as he determines the needs for 1 or 2 bedroom units. Brett has provided a petition that was signed by 11 of 12 of his neighbors in support. The Planning Commission recommended approval at the March 23<sup>rd</sup> meeting. Commissioner Huizenga moved and Commissioner Johnson seconded to set a public hearing for 5:45pm on April 7<sup>th</sup>. Unanimous approval.

Twila Hight, Finance Officer, presented a request to waive the 5% utility penalty on the April and May utility bills. This would allow customers over 4 weeks to make payment before disconnection, with no added fees. Commissioner Mehlhaff moved and Commissioner Barringer seconded to waive the 5% utility penalty on the April and May utility bills. Unanimous approval.

Commissioner Mehlhaff moved and Commissioner Johnson seconded to adjourn. 7:22pm Unanimous approval.
