Sandra Reid and Cassie Hudson presented a street closure request for a Special Event on SD Boulevard on July 23rd from 8:30am to 4:30pm and July 24th from 7:30am to 1pm. The event consists of a planned peaceful protest, speakers, a march, and a sit-in. Commissioner Huizenga moved and Commissioner Barringer seconded to approve the street closure request for the Special Event on SD Boulevard on July 23rd from 8:30am to 4:30pm and July 24th from 7:30am to 1pm. Unanimous approval.

Sharon Pruess, City Planner, presented a plat of lots 13R and 15R, Block 2, in Highlands Ridge First Addition by Travor Diegel. Diegel proposed to replat two existing lots to include existing lawn and a sprinkler system that are located on the neighbor's property. The lot swap does not appear to negatively impact utility easements or services or decrease the frontage of the adjacent lot.
