August 25, 2020**

The City of Pierre Board of Commissioners met in regular session on August 25, 2020 at 5:30 pm with Commissioners Barringer, Huizenga, Johnson, Mehlhaff and Mayor Harding present for roll call. The Pledge of Allegiance was recited followed by an invocation. The agenda was approved as posted. Pete Oberman commented about the mental health impact of COVID-19 and stated his support for the outside agencies presenting 2021 budget requests tonight. No one else was present for public comment.
