Twila Hight, Finance Officer, presented Ordinance 1847 to supplement the 2022 Park Department budget for the donated scoreboards from Bankwest. Bankwest donated \$30,813 to replace 5 scoreboards at the Oahe Softball Complex. The scoreboards were recently received and installed. The supplement includes the expenditure authority and matching general fund donation revenues. Commissioner Todd Johnson moved and Commissioner Huizenga seconded to approve Ordinance 1847 AN ORDINANCE ENTITLED AN APPROPRIATION ORDINANCE SUPPLEMENTAL TO ORDINANCE 1839 THE 2022 ANNUAL APPROPRIATION ORDINANCE TO APPROPRIATE FUNDS FOR NECESSARY FUNCTIONS OF GOVERNMENT FOR WHICH NO APPROPRIATION OR INSUFFICIENT APPROPRIATIONS WERE PROVIDED. Unanimous approval.

Val Keller, Solid Waste Manager, presented the request to purchase a GPS software system and related equipment to be installed on the equipment at the regional landfill. The system would be purchased from RDO Equipment off MN cooperative pricing for \$121,745. The system will provide survey and compaction information to employees while they are working and also into a system Val can access from her office. Now that the operations have moved above ground, the survey data will be very important. The compaction information will also help avoid over compaction or less than adequate compaction. Commissioner Huizenga moved and Commissioner Barringer seconded to approve the purchase of GPS software system and related equipment from RDO Equipment for \$121,745.

Sharon Pruess, City Planner, presented the Plat of 424 W Capital to be replatted with 116 N Onida. Central State Properties has purchased these 2 properties and demolished a multi-family housing structure. They propose to replat and move in a ranch style home that would be remodeled as a duplex with 2 units. Commissioner Huizenga moved and Commissioner Vona Johnson seconded to approve of Resolution 2730 as presented. Unanimous approval.

Matt Elbersen, Building Official, presented a moving permit for Central State Properties related to the previous request. The structure is in excellent condition and would be brought up to current building code. Commissioner Huizenga moved and Commissioner Vona Johnson seconded to approve the moving permit for 424 W Capital Avenue. Unanimous approval.

Nick Waters, Staff Engineer, presented Change Order #2 on the Wastewater Plant Redesign project for an additional \$39,219. The change includes 5 small items but does not extend the time. Commissioner Barringer moved and Commissioner Todd Johnson seconded to approve Change Order #2 on the Wastewater Redesign project for an additional \$39,219 as presented. Unanimous approval.

Bob Riter, Assistant City Attorney, presented the International Brotherhood of Electric Workers Union (IBEW) Contract for 1/1/2023 thru 12/31/2024. Minor changes include the \$2 per hour salary increase for all employees and salary adjustments on 1/1/2023 of 2.75% and 1/1/2024 of 3%. Commissioner Vona Johnson moved and Commissioner Todd Johnson seconded to approve the IBEW Contract for 1/1/2023 thru 12/31/2024 as presented. Unanimous approval.

Commissioner Huizenga moved and Commissioner Vona Johnson seconded to adjourn. 6:02 p.m. Unanimous approval.
