Val Keller, Solid Waste Manager, presented the request to purchase a Kubota Skid Steer and attachments for the Landfill. The skid steer is a 2023 budgeted item with an expected delivery in early 2023 and would be purchased from Floyds Kubota off a Source Well contract for \$63,221.70. Commissioner Huizenga moved and Commissioner Barringer seconded to approve the purchase of the Kubota Skid Steer for the Landfill from Floyds Kubota for \$63,221.70.

This being the time and place for the public hearing to consider a Temporary Malt Beverage License for Capital City Liquor at Dakota Spirits Distillery on October 14, 2022, Mayor Harding opened the hearing. Micah Honeywell from the Pierre Area Chamber of Commerce presented the request and provided an overview of the planned Ringneck Roundup event. Honeywell explained the event was to welcome hunters to Pierre and showcase the distillery. The event was planned for 3 to 10 pm on October 14 and is open to the public. Being no one else present to comment, Mayor Harding closed the hearing. Commissioner Huizenga moved and Commissioner Todd Johnson seconded to approve the Temporary Malt Beverage License for Capital City Liquor at Dakota Spirits Distillery on October 14, 2022.

Commissioner Barringer moved and Commissioner Todd Johnson seconded to adjourn. 5:59 p.m. Unanimous approval.
