Bryan Tipton, Golf Superintendent, presented a request to purchase the Bobcat S62 T4 Skid Steer Loader. This is a 2022 budgeted item from NASPO Pricing for \$47,035.58. Commissioner Todd Johnson moved and Commissioner Vona Johnson seconded to approve the request to purchase the Bobcat S62 as presented. Unanimous approval.

Bryan Tipton, Golf Superintendent, presented the Toro Lease Agreement with Midwest Turf & Irrigation. The lease agreement includes 11 new pieces of equipment, a new Irrigation system, and trade-in of 7 old pieces of equipment. The agreement is for 4 years at \$84,283 per year. At the end of the agreement, the City owns all of the equipment. Commissioner Todd Johnson moved and Commissioner Barringer seconded to approve the Toro lease agreement with Midwest Turf & Irrigation as presented. Unanimous approval.

Commissioner Vona Johnson moved and Commissioner Barringer seconded to adjourn. 5:49 p.m. Unanimous approval.
