The City of Pierre Board of Commissioners met in Regular Session on October 31, 2023, with Commissioners Barringer, Huizenga, Todd Johnson, Vona Johnson and Mayor Harding were present for roll call. Laurie Gronlund, Human Resources Director, presented the 2024 Health and Dental Insurance rates. There is no change to premium rates for health insurance. The deductible for the qualified high

deductible plan will increase from \$3,000 to \$3,200. Outpatient services will be subject to deductible and co-pays in 2024. Mayor Harding moved and Commissioner Vona Johnson seconded to approve the 2024 Health Insurance Rates. Unanimous approval. Dental insurance will have a 5% increase in premium rates. For a two-person party, the rate will be \$16.90 per pay period and the family rate will be \$33.55 per pay period. Mayor Harding moved and Commissioner Huizenga seconded to approve the 2024 Dental Insurance Rates. Unanimous approval.

Laurie Gronlund, Human Resources Director, presented Personnel Policy Revisions to Sections 10, 2.12, 3.1.8, 4.15, and 6.1 relating to circumstances under which drug and alcohol testing will be required or requested for CDL applicants, approval of outside employment and defining time and day employees cannot work outside employment, removing duplicate sections regarding probationary employee, making clarifications for pay period and pay day. Mayor Harding moved and Commissioner Vona Johnson seconded to approve the Personnel Policy Revisions to sections 10, 2.12, 3.1.8, 4.15, and 6.1 as presented. Unanimous approval.

Brad Palmers, Utilities Director, presented a request to purchase an air compressor for the water department. The purchase is a 2024 budget item with a lengthy lead time. The quote is from Bierschbach Equipment and Supply for \$29,870. Commissioner Barringer moved and Commissioner Todd Johnson seconded to approve the request to purchase the air compressor for the water department from Bierschbach Equipment and Supply for \$29,870. Unanimous approval.

Gidget Palmer, Project Manager, presented the 2023 Manhole Lining Project Agreement with Mocon Pacific Inc. The project would be for rehabilitation of six manholes for a total of \$39,450. Substantial completion for the project would be April 2024. Commissioner Huizenga moved and Commissioner Vona Johnson seconded to approve the 2023 Manhole Lining Project Agreement with Mocon Pacific Inc for \$39,450. Unanimous approval.

Gidget Palmer, Project Manager, presented the Burns and McDonnell Engineering Agreement Amendment #8. This amendment is for additional design services regarding the final clarifier and replacement of mechanism. The project will be completed using CMAR project delivery method. The total for this amendment is \$159,508 with a completion date of February 29, 2024. Commissioner Barringer moved and Commissioner Vona Johnson seconded to approve the Burns and McDonnell Engineering Agreement Amendment #8 for the design of the final clarifier and to replace the mechanism for \$159,908. Unanimous approval.

Commissioner Vona Johnson moved and Commissioner Huizenga seconded to adjourn. 5:59 pm. Unanimous approval.
